The City of Diamond Bar's Summer Day Camp is an eleven week recreational program at Heritage Park that gives children ages 6-12 that very experience in a safe, well monitored environment. Camp activities include two excursions per week, one pool or hike trip, plus daily activities such as arts and crafts, indoor and outdoor sports and activities and much more.

Major excursions such as Disneyland, Knott's Berry Farm, Raging Waters and the La Mirada Splash allow campers to experience much of what Southern California has to offer in the way of theme parks while minor excursions, such as laser tag, bowling and roller skating keep kids moving and encourage an active lifestyle! In addition to these trips, campers visit a local swimming pool or hike a local trail weekly. DB Summer Camp is packed with trips and activities that give campers the opportunity to get the most out of summer with new friends and old!

Please note that the times and dates of excursions listed in this brochure are subject to change. Your child will be supervised by highly trained, experienced, caring, and responsible camp leaders with a child ratio of 10:1. You may register for any number of weeks by leaving a deposit or paying for the weeks in full. Payment for weeks with deposits are due the Monday before the week starts.

- **Priority Registration for Diamond Bar Residents** (Proof of residency required!) **begins on March 14, 2016.**
- **Open Registration begins on April 11, 2016.**
- **Campers must turn 6 before attending camp.**
- **New participants under the age of 8 must provide a birth certificate upon registration.**
- **A week may be reserved in advance with a \$65 non-refundable, non-transferable deposit.**
- **Refund requests must be received two (2) weeks in advance and will only be considered for weeks paid in full at the time of registration.**
- **Summer Day Camp is limited to 100 Participants on a first come, first served basis.**
- **Final weekly balances must be paid by the Monday prior to the start of the reserved week.**
